Friend:

The No Bats Baseball Club continues its strong commitment to the Wounded Warriors who have served and sacrificed so much for our country.

I ask your assistance in helping No Bats support a charity that provides Service Dogs to disabled war veterans: Canine Companions for Independence (CCI), http://www.cci.org/Veterans. I have already made a substantial donation. Can we count on your tax-deductible contribution to Canine Companions to help provide a wounded veteran with an assistance dog? Full tax benefits go to each donor, as Canine Companions is a tax-exempt charitable organization (ID number 94-2494324).

WHAT/Why?

For a veteran returning home with life changing injuries, the challenge of rebuilding a normal life starts with re-fashioning a life of personal independence. An assistance dog can provide the help these men and women need to regain that independence, and Canine Companions is the nation's top training facility for matching the right dogs with people in need. A non-profit organization that runs on charitable contributions, CCI invests two years in the meticulous preparation of a dog for a life of dedicated service. Each dog is methodically trained for a life supporting handicaps of differing needs; some assist people in wheelchairs with physical disabilities, while others are trained to assist the deaf and hard of hearing. Many are trained to open doors, retrieve fallen items, and pull a wheelchair. Warrior dogs are taught to support the needs of men and women with forced limitations from missing limbs.

The estimated cost of providing a service dog to a Wounded Warrior, which involves breeding, training and follow-up services, is around \$45,000.

No Bats is not the first to support CCI. Canine Companions was the charity of choice for the late cartoonist Charles M. Schulz, who helped fund CCI's northern California campus, see

In a recent CCI newsletter article you'll find the following quote from Major David Rozelle US Army, who lost his foot when his Humvee ran over a land mine during Operation Iraqi Freedom:

"I've spent ten years at war. I've served three tours of duty. And I've lost my leg. I've had some pretty bad days...but I haven't had a bad day since Domi came into my life. From the moment she bounces out of her crate wagging her tail every morning to when my boys tell her goodnight—I've never been so happy..."

Even though there is never enough money for us to help all of those who could use help, No Bats is going to help. I ask for you to help as well.
